ARTS AUTHORITY UPDATE

David Flynn, Senior Vice President, Public & Community Affairs, provided an overview of the Service Agreements and commitment levels to Wayne, Oakland, and Macomb county residents. Recent efforts include the development of a communication plan to tell the public about the DIA. Core messages include the following: 1) The DIA is a leader in education, 2) the DIA is part of the comeback of Detroit, and 3) the DIA offers a unique history that you cannot find elsewhere. A communication tool-kit is currently being developed to aide in message sharing. It was proposed at the meeting that DIA also engage in public forums at city meetings.

PLAZA REPORT

Felicia Molnar provided an update on the Plaza Project. Finalists presented on January 23rd to consider transformation of the neighborhood in cultural district (12 institutions). Concepts considered parking underground and other spaces. Next steps – Questions prepared by Jury to circulate to submitters, prior to winner selections.

Robert Bowen provided FY 2019 Six Month Financial Summary.

John Steele introduced Ellen Hanspach-Bernal and Aaron Steele. On January 14 & 15, 2019, the DIA hosted a workshop for 40 local FBI agents on art theft and recovery. Outcomes of this collaboration were the sharing of investigative methodologies and documentation. It also set the stage for future collaborations. While onsite the agents participated in tours, art handling and packing training, lectures, and conservation workshops.

Next week, paintings conservator will begin a series of Thursday sessions titled *Conservation Live*. The conservation and presentation with Q&A will take place in the museum and will be hosted by Kress Fellow, Becca Goodman. This program is open to the public.
