 - 5. Fifth, the Executive Officers of the DIA are authorized and directed to take such actions on behalf of the DIA as are necessary or helpful to carry out the intent of these resolutions.
 - 6. Finally, all actions previously taken by the DIA in furtherance of the matters referred to in these resolutions are ratified.

PUBLIC AFFAIRS REPORT

David Flynn, Senior Vice President, Public & Community Affairs, provided an update:

I. Summary of Recent Activity

- A. Dave referred to the Board Case Statement located within the board packet (pages 169-185).
- B. Following the Board vote on November 4th to pursue a March 10th ballot renewal, the DIA has been actively working to share core messaging with key stakeholders and the media.
 - 1. The DIA is a leader in education, providing free field trips, free transportation and access to tens of thousands of students and kids across Metro Detroit.
 - 2. The DIA is a key part of the comeback of Southeast Michigan, attracting new businesses, talent and making our region a great place to live, open a business, or raise a family.
 - 3. The DIA provides one-of-a-kind access to history and cultures not found in books, on TV or on the internet.
 - 4. A *Vote Yes for the DIA* campaign will operate as a separate entity 501(c)(4) to facilitate all activity related to the election.

FINANCE REPORT

Robert Bowen provided FY 2020 Financial Summary.

I. FY 2020 Financial Summary

- A. The DIA's financial performance has been better than budget for the first three months of the 2020 fiscal year.
 - 1. Revenue is \$100,000 unfavorable to budget for the Quarter
 - 2. Expenses are \$200,000 favorable to budget
 - 3. Unrestricted operating results are \$100K favorable to budget
 - 4. Spending from restricted funds is within the plan

III. 2019 FY Financial Statement Audit

- A. Plante Moran completed the audit of the DIA's financial statements for the year ending June 30, 2019, issuing an unqualified opinion on the financial statements stating that:

 - 2. Reasonable judgments and consistency have been applied
 - 3. Financial Statement disclosures are neutral, consistent, and clear
 - 4. Strong cooperation and communication between the DIA and Plante Moran

RESOLVED – Due to an Accounting Standards change, the Audit Committee and Finance Committee recommend that the Board of Directors approve a motion to: Authorize that millage funds be directed to a Board Designated fund, with release of 1/12th of the expected annual collections on a monthly basis from January to December. The Board gives management full responsibility and authority to make the necessary calculations. *Motion: It was moved, supported and carried to approve the resolution.*

DEVELOPMENT REPORT

Gene extended his thanks to the Development team and to the 2019 Gala chairs for an amazing celebration that took place on November 9th.

ENRICHMENT

Eric Drewry, Director of Protection Services provided an overview of a program that our teams use to monitor and respond to hot spots and trends of policy violations that could threaten the DIA's collection. In June, Eric presented our technology-driven COMPSTAT model at the Smithsonian National Conference on Cultural Property Protection in

Washington D.C. and the American Alliance of Museum Interpreters annual Conference hosted by the DIA.

AUXILIARY UPDATES

- I. Friends of African and African American Art (FAAAA): Leland Calloway, Chair summarized their trip to Kalamazoo Institute of Art on October 25th, and the Margaret Herz Demant awards on October 27th. FAAAA also supported the DIA's Gala this year.
- II. Founders Junior Council (FJC): Nate Wallace, Chair announced their goal of this year is to raise the profile of FJC. Stay tuned for announcements of upcoming programming.
- III. Women's Committee (WC): Fay Savage, Chair announced Peter H. Reynolds' visit to the DIA November 14-15, which includes two full days of programming for students and teachers. In addition, on November 14th they will be hosting a fundraiser called The *Dot at the DIA*, netting over \$30K in celebration of the DIA's outreach with Peter Reynolds, award-winning children's author and illustrator.
- IV. European Paintings Council (EPC): Barbara Quilty, Chair announced the EPC's fundraiser in conjunction with the Bruegel exhibition on January 23rd.
