## **EDUCATION, ART & PROGRAMS UPDATE**

Judith F. Dolkart, Deputy Director for Art, Education & Programs, provided an update on Fall K-12 Field Trips (tours begin 10/5), and a Pilot Program with workshops and educators from Wayne, Oakland, and Macomb County under the JusticexDesign framework.

## FINANCE REPORT

Rob Bowen, CFO & EVP, Finance & Operations, delivered a financial update.

## I. FY 2021 Financial Summary

- A. The DIA operated at a reduced schedule (27% fewer hours) with limited visitor capacity
- B. The DIA's galleries were open to visitors, but there were no in-person events or activities. All activities/programs were offered online
- C. The DIA's operating pattern resulted in lower earned income which was offset by stronger fundraising than planned
- D. Due to reduced visitor hours and operations, staff and program expenses were lower than planned in the budget

#### II. FY 2021 Operating Overview

A. The DIA's financial performance is better than budget for the 2021 Fiscal Year

RESOLVED – The DIA received unrestricted gifts that have been directed to the operating endowment. Finalization of the designation requires board approval.

## **DEVELOPMENT REPORT**

Nina Holden, Senior Vice President & Chief Development Officer, Development Operations, provided an overview of recent activity, highlighting a strong year of fundraising and +300 first time donor gifts. Plans for the fall include a smaller sized Fash Bash, and no Gala. A Gala Patron party however will take place, with a date to be announced soon. Membership fundraising is back up to normal speed, with a goal to grow from 17,000 to 20,000 households.

The Planned Giving Policy addendum was circulated to the board in advance of the meeting for approval.
